Thank you for your letter of April 2, 2012, requesting that I dissolve the Washington Flood Market Assistance Plan. You indicated that the participating members of the Plan are unanimous in submitting this request.

It provided a mechanism for those seeking excess flood insurance at a time when coverage was not being offered in the admitted market. At the time the Washington Flood Market Assistance Plan was established in June 2010, there was plenty of cause for concern in the valley, an area of economic and industrial importance to Washington State.
