- (3) This company was admitted to the Quarterly Listing solely to act as successor to the trust fund previously executed by Sphere Drake Insurance Limited (f/k/a Odyssey Re Limited). RiverStone Insurance (UK) Limited is in run off and is not considered eligible to sell in any state's surplus lines market.
- (4) This company is limited to write international travel medical insurance for individuals that reside in jurisdictions that allow such medical insurance to be written on a surplus lines basis.
